



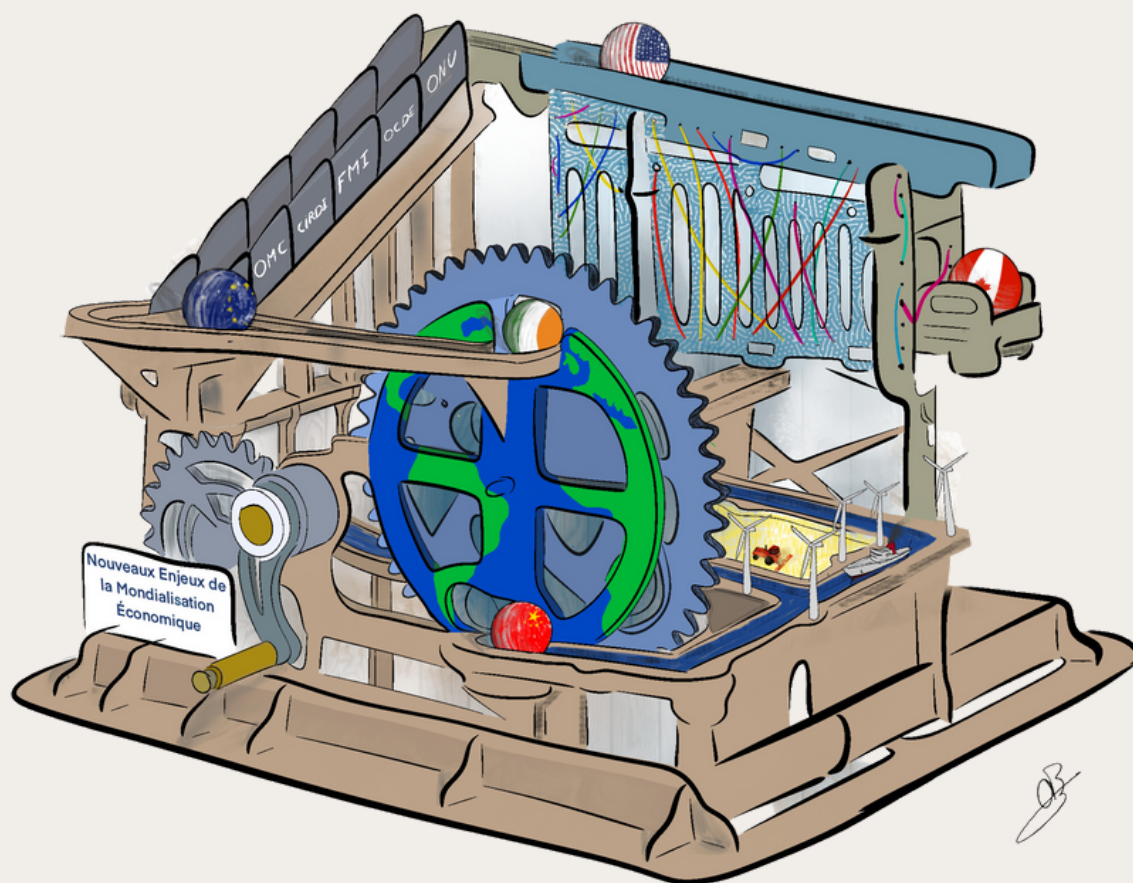

This justifies the need for research on the new challenges of economic globalization. The actors of this economic globalization are today eager for data, answers, arguments and reflections on the challenges and debates that globalization brings us.

The Research Chair on New Challenges of Economic Globalization (NEME Chair) is pleased to invite you to the first edition of its student conference which will take place on May 30, 2023 in hybrid mode (at Laval University and online).

The conference will be an opportunity for undergraduate, graduate and post graduate students from all universities, in disciplines that intersect with the study of economic globalization (international law, political science, international relations, international economics, international multidisciplinary studies, administration, history, geography, etc.), to disseminate their current research work on the challenges of economic globalization in an individual written and oral communication.

Three prizes of \$3,000, \$2,000 and \$1,000 respectively will be awarded to the three best papers presented at the Conference, by a Scientific Committee of university professors and government experts.
